Rules and Regulations:

1. Golfers shall be ready to tee off 15 minutes prior to scheduled start time. Events shall start at scheduled times and golfers shall conclude play within the following times: 9 holes = 2.25 hours; 18 holes = 4.5 hours. An additional \$50/hour will be charged for any overage into the next hour.
2. For "closed-course" events, confirmation of the number of golfers must be submitted 30 days prior to the event and payment received 14 days prior to the event. For "tee-time" events, less than 76 golfers, confirmation of the number of golfers must be submitted 14 days prior to the event and payment received 7 days prior to the event.
3. Payment is required 7 days in advance for tee-times scrambles and 14 days in advance for course closure events.
4. Events may not be cancelled by the customer due to inclement weather. The Raven Rock superintendent or designee will determine if the course conditions deem closure. If conditions warrant closure, management will work with the customer to reschedule the event.
5. The event coordinator will be held responsible for Raven Rock property damage that occurred during the event.
6. Everyone must be ready to tee off 15 minutes prior to the scheduled start time.
7. No alcoholic beverages are permitted to be brought onto Raven Rock property. All alcohol must be purchased from the Raven Rock Golf course. Any outside alcohol brought on the premises may be confiscated by management and persons violating this policy may be asked to leave. No refunds will be issued for any such violation(s).
8. We reserve the right to ask individuals to leave the course without refund.
9. A \$100 deposit will be required to reserve the time for our event and must be paid by _____.
